

# NGV MEMBERSHIP: JOIN NGV MEMBERSHIP AND WIN A PRIVATE TOUR OF THE NGV



## PROMOTION DETAILS

<b>Promoter</b>	National Gallery of Victoria, (ABN: 77 884 986 472) of 180 St Kilda Road, Melbourne, VIC 3006.
<b>Prize Supplier</b>	National Gallery of Victoria, (ABN: 77 884 986 472) of 180 St Kilda Road, Melbourne, VIC 3006.
<b>Entry Restrictions</b>	Open only to Australian residents who purchase a new Concession/Student, Individual, Duo, Family or Premium NGV Membership during the competition period. NGV Membership renewals, Digital Memberships, Teacher/School Memberships, and gift Memberships purchases are not eligible. Entrants must not have held an NGV Membership within the past 12 months. Entrants must be 18 years of age or over.
<b>Competition Period</b>	10am (AEST) on 19 July 2024 to 5pm (AEDT) on 31 August 2024.
<b>Entry Method</b>	All people who join NGV Membership by purchasing one of the following categories of NGV Membership during the competition period will automatically be entered into the competition: Concession/Student, Individual, Duo, Family or Premium Membership.
<b>Draw Details</b>	10am (AEDT) on 03 September 2024 at the Promoter's office.
<b>Winner Determination</b>	The first five valid entries randomly drawn from all valid entries received during the Competition Period will win the prize.
